**MOTION FOR STATUS CONFERENCE ON
EMERGENCY MOTION TO DISSOLVE PRELIMINARY INJUNCTION**

Defendant, Steven Dorfman (“**Dorfman**”), through undersigned counsel, pursuant to S.D. Fla. L.R. 7.1, files this motion for a status conference to discuss the status of Mr. Dorfman’s fully-briefed Emergency Motion to Dissolve Preliminary Injunction, and in support states:

1. On April 22, 2021, Mr. Dorfman served and filed Defendant Steven Dorfman’s Emergency Motion to Dissolve Preliminary Injunction (DE #418) (the “**Emergency Motion**”).
2. On May 14, 2021, the Court held a hearing on the Emergency Motion.
3. Since Mr. Dorfman filed the Emergency Motion the Federal Trade Commission (the “**FTC**”), the Receiver, and Mr. Dorfman have submitted approximately a dozen responses, oppositions, and supplemental briefs in an effort to inform the Emergency Motion. *See* Notification of 90 Days Expiring (DE #439).
4. On August 12, 2021, Mr. Dorfman filed and served his Notification of 90 Days Expiring, notifying the Court that the Emergency Motion was ripe.

5. To date, the Court still has not entered an order determining the Emergency Motion filed on April 22, 2021.

6. Accordingly, Mr. Dorfman seeks a status conference to clarify the status of the Emergency Motion, and to clarify the dates of any related rights to appeal.

7. Undersigned counsel has conferred with counsel for the FTC. The FTC opposes the Emergency Motion but does not oppose this request for a status conference.

WHEREFORE, Defendant Steven Dorfman respectfully requests that the Court set a status conference to discuss the status of the Emergency Motion, and for all further relief that the Court deems just and proper.
